WHY BAN FLAVORED TOBACCO?

Big tobacco and the vaping industry are using flavors to hook a new generation of kids and reversing decades of progress cutting youth tobacco use. In fact, 81% of kids who have ever used a tobacco product started with a flavored product. In addition to targeting kids, these products have been heavily marketed to communities of color for decades, resulting in a disproportionate use of these products by African Americans who are more likely to die from smoking-related illnesses than white smokers.

The organizations listed below support S428-A, Hoylman/A47-A, Rosenthal which would ban the sale of flavored e-cigarettes and S6809, Hoylman/A8808, Bichotte which would ban flavored combustible and smokeless tobacco, including menthol cigarettes. This two-bill package will ban the sale of flavored tobacco across New York State and prevent kids from ever picking up a tobacco product.
